GCSE PE Rock-Climbing Sessions

All GCSE PE students are required to have three practical assessments as part of their final grade. Your son/daughter has expressed an interest in rock climbing, to ensure they reach all requirements and have the best possible opportunity of success at GCSE; we have arranged a series of seven rock-climbing sessions at K2 Crawley.

These seven sessions will take place on **Wednesday evenings from 6.30-8.00pm** at K2 on **5th June, 12th June, 19th June, 26th June, 3rd July, 10th July** and the last session on **17th July**. Please meet me at K2's reception at 6.15pm. Students must attend all seven sessions in order to be assessed. If you are not interested in your son/daughter attending these sessions as they have another sport you can video independently, please let me know as soon as possible.

Please arrange for your son/daughter to get to and from the venue for each session. Students should wear comfortable clothing suitable for this activity and bring a drink if they wish.

The total cost for the five sessions for each student is **£89.00**, which covers activity costs and insurance. Payment may be made in full or in two instalments of £44.50 with the final payment before the last session on Wednesday 17th July. Please note that we are only accepting payment via Parent Pay. If this creates difficulties for you please contact our Bursar, Mrs Botting, directly, either by email at jbotting@imberhorne.co.uk or by telephone via the main school switchboard.

Under current legislation I am obliged to point out that the contribution is voluntary but I must inform you that unless all parents who are able are willing to contribute, the event may not take place. Limited financial assistance is available in certain cases. Please contact Mrs Botting, Bursar on jbotting@imberhorne.co.uk in confidence if you are unable to contribute so that suitable arrangements can be made or if you have any queries or difficulties regarding the on-line payment system.

Please also ensure your son/daughter has any medication that they may need, clearly labelled, and that this is given to a member of staff prior to the events commencing.

We require parental consent in order to take students off-site on trips or to attend events. Parental consent is considered to have been given once the trip or event is paid for on Parent Pay. Please ensure you have completed the required acceptance on Parent Pay by **Monday 20th May**. We will use the emergency contact details we have on our database for your child for this trip.
